On Wednesday, April 28, 2010, fourteen Chambers of Commerce will hold a “**TASTE**” in conjunction with our **2010 Multi-Chamber Networking Extravaganza**. Tabletop exhibits are available for \$50 (value \$200) to any *member* restaurant, caterer, deli or banquet hall who wishes to offer *complimentary* samples of their food during the event.

The Multi-Chamber **Networking Extravaganza** will be held at The Meadows Club, 2950 W. Golf Road in Rolling Meadows from 4:00 p.m. to 7:00 p.m. Expected attendance is 400 business people.

Each **Taste** participant will be invited to showcase their delicacies/food samples, distribute menus, and meet potential customers. We ask that you provide a minimum of 200 food samples, highlighting one or two of your specialties. The Chamber will provide a 6-ft. skirted table with two chairs, and table signage. In addition to handing out food samples, restaurants will be able to sell Gift Certificates at their booth.

There will be no cooking allowed on site so food will have to be transported from your business location. There is a **\$50 charge** for use of an electrical outlet. We do require a **\$50 booth fee** to be paid with your signed contract. This is to ensure participation and prevent empty booth space throughout the show.

The available food booths are limited so we ask that you **RETURN the enclosed signed and completed contract by March 25, 2010**. This will allow the Chambers of Commerce time to promote your name on event materials. It is important that you respond quickly. Booths will be reserved on a first-come, first-served basis.
